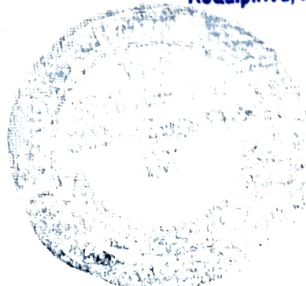

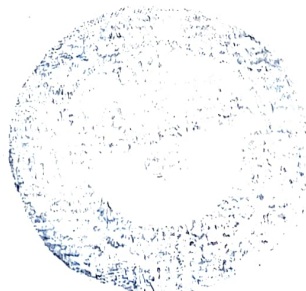
OBJECTS OF THE TRUST :

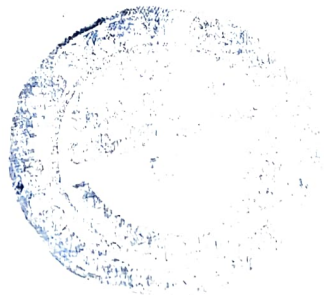

The Trustee shall have power and discretion to accept upon such terms as they shall think fit, any donations, grants, subscriptions, aids and contributions from the Founder and from any other agencies, corporations, organizations, institutions, individuals whether they be in cash or in other movable or immovable property for the purpose of the Trust, PROVIDED ALWAYS that the terms upon which they shall be accepted shall not in any way be inconsistent with or repugnant to the provisions contained in these presents and the objects of the Trust. The Trustees shall apply such donations, grants, aids, subscriptions and contributions for all or any of the objects of the Trust keeping in view the intentions of the donors.

INVESTMENT:

All moneys which shall not immediately be required for current expenses shall be invested by the Trustees in investments and Securities authorized by law for the investment of trust funds and in particular in any of the modes specified under section 11(5) read with section 13(1)(d) of the Income Tax Act from time to time.

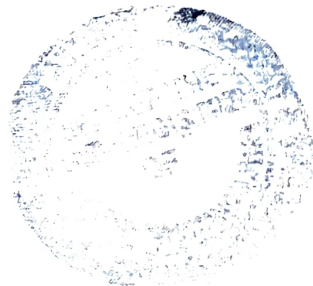

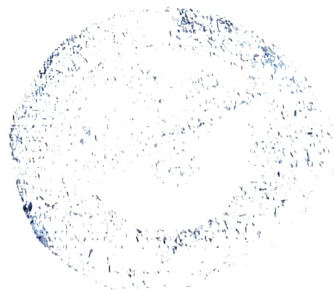

APPOINTMENT AND REMOVAL OF TRUSTEES

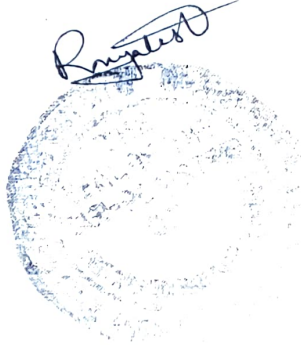

- (vii) becomes otherwise unfit to hold the office of the Trustee by operation of law of some Act.
- (viii) Is Otherwise removed by the members of the Board by decision of majority, if in the opinion of the members the continuation of such a trustee would not be conducive or detrimental to the objects of the Trust.
- (ix) If any trustees act against to the object of the trust , such kind of trustees to be removed from the trust by the author of the trust

In case of any vacancy, by operation of law, resignation due to old age or otherwise of any trustee, the board of Trustees shall nominate one of the persons for life time from the legal heirs of such Trustee, who had caused such vacancy subject to provision below. If the Trustee leaves a nomination appointing any of his or her family members or any person of his choice such a nominee shall be accepted by the Board and authors of the trust. In case there is no nomination, then the eldest of the legal heir shall become the Trustee. The authors of the trust Shall be the Managing committee and the day to day conduct and management of the affairs of the trust shall be carried on by them. The managing committee shall not be ceased once appointed they continues up to the life time of the trust.

CONSTITUTION OF THE TRUST

- (1) The Trust shall be Irrevocable.
- (2) The Trustees shall be entitled to be reimbursed for all expenses incurred by them in carrying out the object of the Trust.
- (3) The Trustees shall not entitle to any remuneration and shall work in honorary capacity. They shall however be entitled to receive the out-of-pocket expenses incurred by them in the Course of discharging their duties.
- (4) The income and funds of the Trust will be solely utilized towards the object and no portion of it will be utilized for the payment to Trustees by way of profit, interest, Dividends etc.
- (5) Trustees may, by deed or deeds stated to be supplemental hereto any of the provisions of this deed provided that no amendment may be made in object clause and winding up and dissolution clause.
- (6) Any amendment to Trust Deed will be carried out only with the approval of the commissioner of income Tax.
- (7) The benefit of the Trust is open to all irrespective of Caste, Religion, and Sex etc.

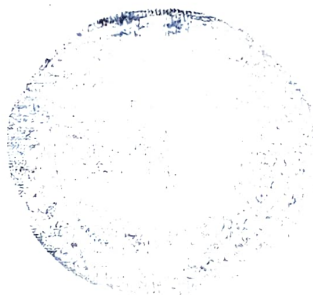
POWER OF THE BOARD OF TRUSTEES:

1. The Board of Trustees shall have power to accept donations either in cash or in kind or immovable properties either with or without any special conditions.
2. The Board of Trustees shall be competent from the time to time to frame, make, amend and enforce all such rule, regulations, bye-laws not inconsistent with the express provisions of this trust as the Board of Trustee may deem proper for securing and facilitating the administration and management relating to the activities and affairs of the trust.
3. The Board of Trustees shall have power in general to do all acts necessary to carry out the objects of the Trust.
4. The Board of Trustees shall have the power to deposit the Trust money or any portion thereof in any Nationalized Bank or Banks either by way of Fixed Deposit or in Current Account or in Savings Bank Account.
5. To have control over the assets of the Trust and to executive, become party to, to sign, acknowledge, perfect and register all deeds, agreements and writing and to given effectual discharge on behalf of and against the Trust.
6. To draw, make, accept, endorse, discount, negotiate execute, cheque, bills of exchange and other negotiable instrument.
7. Maximum Number of trustees shall be Twenty five.
8. The Trust shall invest its money and funds in such modes as are in accordance with the provisions of income tax Act as amended from time to time.
9. If in the opinion of the Board of Trustees any property belonging to the Trust is deteriorating in value or is not yielding reasonable income or that its sale or conversion into property of another kind would be advantageous to the Trust, the board may exchange the same for property of another kind or sell the property and invest the proceeds in the manner hereinafter provided.
10. or the purposes of carrying out of the objects of the trust, the Board of Trustees shall have the Power to purchase or to take lease any immovable properties and in case of vacant land, the Trustee shall be at liberty to erect building thereon and to do all acts necessary thereof.
11. The Board of Trustees or the authors of the trust shall be entitled to enter into any agreements and to raise funds by way of loans.

13. The entire control, regulations, management, application and administration of the trust Properties whether capital or income, rent, interest or profit of any kind shall be discretion of the Trustees.
14. Every power, authority of discretion conferred upon the All the Trustees shall be exercised or signified either by some instruments in writing be signed by all the Trustees.
15. The Board of trustees shall sue and be sued in court of Law for and on behalf of the Trust.
16. The authors of the trust shall have the power to appoint, remunerate, control discipline and remove the employees of the trust. and related institutions run by the trust. The Activities to be held with the approval of the authors of the trust.
17. The Board of Trustees shall have the power to settle out of Court, compromise, or compound all suits, actions, other proceedings and all differenced, and demands to submit for arbitration, to execute, release and to settle and approve all accounts without being answerable for any loss occasioned thereby.

MEETING OF BOARD:

1. Meeting of the Board of Trustees shall be held at least once in every three months but any number of other meetings may be held as and when considered necessary. The Managing Trustee shall hold meetings of the trust.
2. A Minute book shall be kept by the Trustees. All proceedings of meetings of the Board of Trustees shall be entered in the Minute book and shall be signed by the Chairman of the meeting at the conclusion thereof.

4. All Proceedings and questions and matters arising at the meeting of the trustees shall be decided by majority of vote and in case of equality of vote the presiding officer shall have second or casting vote.
5. The Board is hereby authorized and may from time to time make additional rules and bye laws regulating for carrying out the objects out the objects of the trust, Investment of the trust Funds and their Utilization of thereof and all other matters incidental to the working of the trust and from time to time modify, alter or amend such bye-laws and rules provided that no such bye-laws shall be in any way alter or contravene the object of the trust and the approval of the authors of the trust the changes has to be carried out in the trust .

CUSTODY OF DOCUMENTS:

The Managing Trustee or the author of the trust shall have the custody of all deeds and documents of title relating to the Trust properties and investments and the books of account and other records relating to the Trust and shall be responsible for the same.

All income subscriptions and pecuniary donations of the Trust and income from investments shall be paid into a banking account or accounts with any scheduled bank, which the Trustees may determine unless immediately needed for the purpose of the Trust.

MANAGEMENT OF THE TRUST:

With a view to carry out the objects of the Trust here in above mentioned and to augment its funds and to administer them. The author of the trust shall have the power to appoint committees or sub-committees from among the Trustees and assign duties and seek suggestions for the purpose of working of the Trust.

ACCOUNTS AND AUDIT:

1. Proper and regular books and accounts of all receipts and expenditure of the trust shall be maintained by the trustee's either in English or in Tamil.
2. On the 31st March of every year a General Account shall be taken for all the Assets and Liabilities of the trust and an Income and Expenditure Account for the whole year and the Balance Sheet as on 31st March shall be prepared and shall be passed by trustees. The Accounts of the trust shall be audited annually by a Chartered Accountant appointed by the Trustees for the purpose.

ADMINISTRATION:

1. The Board of Trustees or the authors of the trust shall have the full power of management of the Trust properties and funds and they shall have full controls over the finance of the Trust. They shall likewise have full powers of supervision over the Charitable Institutions, Schools, Colleges, Hospitals and all the establishments falling within the objects of the trust.
2. Subject to the supervisions of the Board and subject to the express provisions herein contained, the Managing Committee shall have Power of Management Conduct, administration of the affairs of this Charitable Trust and its educational Institutions, Hostels, Boarding Houses conducted by the Trust.

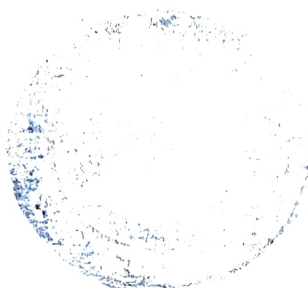
WINDING UP AND DISSOLUTIONS:

ANNUAL MEETING AND AUDIT REPORT:

1. There shall be annual meeting of the Board of Trustees and General Body where the annual report of the trust with an annual and audited statement if Account shall be considered and adopted. The Managing Trustee or the author of the trust at such meeting submits a budget for the Receipts and Payments of the Trust for the Coming Year.
2. The Board shall consider at such meeting the auditor's Report and the budget of the Trust and if the same is approved shall record such approval by a resolution to effect.

BANK ACCOUNTS:

The Trust shall operate the Bank Account in the name of the Trust the author of the trusts/SECRETARY AND TREASURER jointly authorized to open Current Account / Savings Bank Account or may other type of Account in any Bank as deemed fit and to operate the same and to execute the necessary documents for receiving loans through Banks.

The Trust shall borrow funds from the Nationalized Bank or Scheduled Bank, Financial Institutions or private Financiers for the purpose of the Trust and such Borrowers shall be done jointly only and it will be binding on the trust, further all the Trustees are empowered to pledge, Hypothecate the property both movable/ Immoveable of the trust for securing the loan obtained from the Nationalized Bank / Scheduled Banks, Financial Institutions or Private Financiers for the purpose of the TRUST.

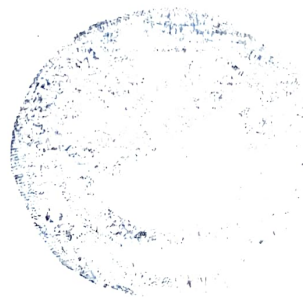
RESIDUARY
